## General Terms & Conditions or Contract:

- (a) CCTV Camera shall have quality system compliance and shall be STQC /TEC/BIS etc certified as applicable to the equipment.
- (b) An under taking from vendor stating that service and supports center are available in Madhya Pradesh.
- (c) Bidder should submit self-attested copies of documents mentioned in the technical specifications in a sealed envelope labelled as envelop A- technical Bid and bidder should submit a separate envelope labelled as envelope B- Financial Bid which should contain only annexure 2 with clearly filled price quote of a unit inclusive al all taxes and charges. Quote price should be written in numerical as well as words without any scribbling of overwriting. All the envelops should be sealed properly
- (d) Both the envelop-e A and envelope B should be submitted in a third envelope labeled as envelope for participation in bid for supply of Wifi Camara at the invard section of the office of the Dean Sundarlal Patwa Government Medical College Mandsaur (M.P.)
- (e) Tender has been called for in the names of items required for CCTV surveillance system and related accessories, the tenderers should quote the rates for the required items including installation at required place in Government Medical College, Mandsaur. The composition and specification of each product should be as per details given in Annexure-II. Any variation, if found, will result into the rejection of the tender.
- (f) The tenderer should mention the name of manufacturer of the product being quoted.
- (g) Rates should be inclusive of installation, fixing, commissioning of CCTV. The rates also should be inclusive of excise Duty, Customs Duty, Transportation, Insurance, and any incidental charges but exclusive of GST/IGST should be quoted for each of the required items and separately on door delivery basis (FOR Destination).

## 2. Eligibility Criteria:

The Tender should fulfill the following eligibility criteria.

- (a) Self-attested copy GST Registration Certificate.
- (b) Self attested copy GST Clearance Certificate (Gstr-3B) of month of July/ August 2025.
- (c) Self attested copy of income tax clearance certificate (ITR) of last three financial years .
- (d) Annual turnover statement Minimum 05 Lac per annum of three financial years, Turn Over certificate should be prepared by practicing chartered accountant.
- (e) Self attested copy of CCTV camera details and CE/STQC/TEC/BIS certificate.
- (f) Non Black listed certificate on 100/-rs non judicial stamp.
- (g) BOQ Compliance on letter head of firm/Company

**3. Validity of Tender:**

Tender shall be valid for 180 days.

**4. Evaluation of tenders:**

- (a) The Purchase Committee constituted by the Tender Inviting Authority, shall evaluate the tender with reference to technical requirements and various other commercial criteria given in the tender document.
- (b) The total rate of all items, exclusive of Sales Tax/VAT/GST/IGST (landed price) shall be considered for evaluation of price and determining L-1 Tenderer.
- (c) No complaint shall be entertained by the Tender Inviting Authority after the opening of financial bid.

**5. Performance Security Deposit and Award of Contract:**

- (a) The Tenderer who has quoted lowest rate for all Items shall be considered for award of contract.
- (b) The successful tenderer shall execute an agreement on a non-judicial stamp paper of value of Rs. 500/- (Stamp duty to be paid by the tenderer) within 15 days from the date of the intimation from tender inviting authority informing that his tender has been accepted.
- (c) If the successful tenderer fails to execute/sign the agreement within the specified time or withdraw his/her tender or owing to any other reasons, his purchase order shall be cancelled besides debarring the tenderer for a period of one year.

**6. Placement of Purchase Orders and Delivery Requirements:**

- (a) The tender inviting authority shall place individual purchase orders for supply and installation of CCTV camera and/or its accessories during the period of 180 days from the date of signing of contract with successful tendered (s).
- (b) The quantity of items will be as per requirement.
- (c) The supplier should complete the supply and installation of CCTV camera and/or installation of CCTV camera and/or accessories wherever required in Sunderlal Patwa Government Medical College, Mandsaur within 03 days from the date of issue of purchase order. All items supplied onsite installation & guarantee is compulsory without charge.
- (d) If at any time the tendered has, in the opinion of the tender inviting authority, delayed the supply of items due to one or more reasons related to force Majeure events such as riots, mutinies, wars, fire, storm, tempest or other exception events, the time for supplying the equipments may be extended by the tender inviting authority/ordering authority at its discretion for such period as may be considered reasonable. However such extension shall be considered only if a specific written request is made by the tenderer within 2 days from the occurrence of such event. The exceptional cause does not include scarcity of material, Power cut and labor disputes.

**Quality Testing Requirements:**

- (a) The items including its packing (packaging) to be supplied, shall be of the best quality & STQC/TEC/BIS certified and shall comply with the specifications given in the tender Document.
- (b) All items should be supplied with quality certificate/ guarantee card as provided by the OEM
- (c) If any of the items supplied by the tenderer found to be Not of Standard Quality after the delivery, the tenderer should supply the whole equipments quantity again irrespective of consumption of that particular. The whole supply should be taken back within 7 days by the supplier at his/her own cost otherwise no claim in this regard shall be entertained.

**8. Payment Terms:**

If supplied items are found not of standard quality then whole payment will be withheld and shall be released only after receipt of replacement of equipments which were found not of standard quality.

**9. Settlement of Disputes:**

- (a) The purchaser and the supplier shall make every effort to resolve, amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the contract.
- (b) No appeal shall be preferred while the tender is in process and until tender is finalized and notification of award is issued by the purchaser.
- (c) In the events of any dispute arising out of the tender or orders, the same shall be settled in accordance with the Arbitration and Conciliation Act, 1996. The venue of arbitration shall be the place of tender inviting authority, Mandsaur M.P.
- (d) In the event of any dispute arising out of the tender or orders such dispute would be subject to the jurisdiction of courts of Madhya Pradesh at the place of tender inviting Authority Mandsaur M.P.
- (e) In no event will the tender inviting authority be liable for any loss of profits, loss of savings, or incidental, indirect, special or consequential damages 'arising out of' or 'in relation to the' present tender.
- (f) Neither the tender inviting authority shall be liable for any claims, losses, costs, damages of any nature whatsoever nor the tenderer shall claim expenses for any cause or causes, including any legal liability arising out of or in relation to the present tender.
- (g) The tenderer shall be solely responsible for any deficiency in services and supplies given by him including the quality and specification of items.
- (h) The maximum liability of tender inviting authority shall be limited to the extent of Payment of goods delivered as per terms of this tender document. The college administration shall not bear any other financial liability such as interest on delays etc.
