

The agency should meet the minimum eligibility criteria:

1. A minimum experience of three years in the field. (Copy of Firm Registration )
2. Valid documents in support of experience of providing same equipment in a medical institute.
3. Agency should have valid GST registration.
4. Copy of PAN Card.
5. Income tax return acknowledgement of 3 years is required.
6. Agency should have Annual Turnover of not less than Rs. 5000000/-.(Rupees Fifty lakhs only)
7. The offer must be supported by tender fee of Rs. 1000/- (Rupees One Thousand only) and EMD of Rs. 50,000/- (Rupees Fifty Thousand only) in the form of FDR/Bank Guarantee.



## General Instructions to Bidders

1. **The tender is "Two Bid" document.** The technical bid should contain all the relevant information and desired enclosures in the prescribed format along with Earnest Money Deposit (EMD) and Tender fee. The financial bid should contain only financial aspect of quoted rates, rates should not be disclosed anywhere in the technical specification papers.
2. The Contracts concluded as a result of this Tender Inquiry shall be governed by the 'Terms & Conditions' and other relevant instructions as contained in this Tender Document.
3. **The name and signature of bidder's authorized person should appear on each page of the tender. All pages of the tender document shall be numbered and submitted as a package along with forwarding letter on agency's letter head.**
4. Tenders received without Tender Fee and EMD amount will not be considered at all.
5. Refund of Earnest Money Deposit: The EMD submitted by unsuccessful bidders shall be returned to them without any interest whatsoever, within 15 to 90 days after conclusion of the contract with successful bidder. The EMD submitted by successful bidders shall be returned to them after the successful bidder deposits the performance security according to conditions stipulated in the bid document.
6. Bidders may note that if the date of tender opening given in this Tender Document is declared to be a gazette holiday, the tender shall be opened on the next working day at the same timing. In such an event the closing hours for receipt of tenders in will stand automatically extended up to 15.00 hours of the next working day in the Government offices.
7. At any time prior to date of submission of tender, Tender Inviting Authority may, for any reason, or decision, modify the terms & conditions of the tender document by a corrigendum. In order to provide reasonable time to take the amendment into account in preparing their bid, Tender Inviting Authority may or may not, at his discretion, extend the date and time for submission of tenders.
8. Tendering firms are at liberty to be present or authorize a representative to be present at the opening of the tender at the time and date as specified in the Schedule. **The name and address of the representative authorized to attend the opening of the tender on behalf of a tendering firm should be indicated in the tender. The representative so deputed should also bring with him a letter of authority from the firm for having been authorized to be present at the time of opening of tender. Only one representative per firm shall be permitted to attend the opening of the tender.** The name and address of permanent representative of the firm, if any, should also be indicated in the tender. Representatives of firms who have not submitted the tender or representatives not possessing authority letter from the bidders or outsiders shall not be allowed to attend the tender opening process.
9. **BID PRICES:**
  - a) The bidder shall give the total **composite price (inclusive of GST)** as per price schedule given in Annexure. The offer shall be firm in Indian Rupees only.

**Penalty Clause:**

1. Poor performance or non compliance to the terms and conditions of the contract will lead to a penalty of 10 percent of the total quoted amount by the firm.
2. In the event of failure to supply or maintain the goods/articles/perform services as per Work Order within the stipulated period, the security deposit may be forfeited and firm will be blacklisted for any future work.

**GOVERNING LAWS AND SETTLEMENT OF DISPUTE**


- 1.1.1 The contractor shall be responsible for all rules/regulations of Central and State Government.
- 1.1.2 Any claims, disputes and or differences (including a dispute regarding the existence, validity or termination of this Contract) arising out of, or relating to this contract including terms may be resolved through joint discussion of the Authorized Representatives of the concerned parties. However, if the disputes are not resolved by the discussions as aforesaid within a period 30 days, then the matter will be referred for adjudication to the arbitration of a sole arbitrator to be appointed by the Client in accordance with the provisions of the Arbitration and Conciliation Act 1996 and rules made there under including any modifications, amendments and future enactments thereto. The venue for the Arbitration will be Mandsaur and the decision of the arbitrator shall be final and binding on the parties.
- 1.1.3 Jurisdiction of Court: This Contract is governed by the laws of Republic of India and shall be subject to the exclusive jurisdiction of the courts in Mandsaur.

## **Terms & Conditions of Tender**

- 1) **Language:** The language of the Tender shall be in English.
- 2) **Documents to Accompany Tender:** The Bidder shall submit the Documents mentioned in the Eligibility Criteria of the Tender.
- 3) **Return of Earnest Money :-**
  - a. After finalization of the Tender, the deposited Earnest Money will be returned back to the unsuccessful bidders.
  - b. On receipt of Security Deposit, the deposited Earnest Money will be returned back to the successful Bidders.
- 4) **Deposition of Security Money:-** The Selected bidders must deposit the requisite amount of Security Money (5% of the approximate value of accepted items) within the stipulated date specified in the acceptance letter. The approved firm shall deposit the Security Money in the form of FDR/Bank Guarantee at SPGMC, Mandsaur duly pledged in favour of Dean, Sundarlal Patwa Government Medical College, Mandsaur(M.P.).

- 7) **Payment:** 100% Payment will be made by accounts department after performance of job as per Annexure against work order on submission of invoices in triplicate along with inspection report, original copy of work order/supply order and receipt vouchers duly verified by the Store Incharge/ Project Head of research produced funded by ICMR.






